## RENT AND ACCOUNT

Rental fee amounts to  euros, tax included, payable at the latest on handing over of keys. The price of electricity, water, gas, heating as well as cleaning services at departure are included in rental fee.

To validate the booking, an account of 20% of rental fee - or  euros - must be settled by bank transfer or PayPal within 96 hours (working days) on reception of rental contract.

If the lodger does not proceed to a full settlement (80% of rental fee) on arrival, the owner will dispose of the premises without having to reimburse the account paid in.

**IMPORTANT :** Arrival after 23h00 (11 pm) or departure before 6h (6 am) in the morning costs an additional 25 euros to be paid on the spot.

## MEANS OF PAYMENT

The payment of the account (20%) will be done exclusively by bank transfer or PayPal. Full settlement (80% remaining) will be done when keys are handed over, in EUROS exclusively.

**IMPORTANT :** Any bank charges are at the lodger expense.

## DEPOSIT

On keys handover, the lodger will be asked to leave a security deposit (check or cash accepted) of an amount equivalent to 150 Euros (all currencies accepted) in order to insure the equipments put to your disposal during your stay. This security deposit will not be paid in and will be returned to the lodger after the inventory of fixtures.

If the cost of damage created exceeds the amount of the security deposit, the lodger is committed to settle the loss after inventory of fixtures. In return, the owner is committed to justify the amount required for repairs.

In case of a dispute which cannot be solved with an amicable arrangement, the county court where the premises are located is sole capable.

**IMPORTANT :** The security deposit cannot be considered as participation to a settlement of rental fee.

## INVENTORY OF FIXTURES

An inventory of fixtures will be done on arrival and on departure of the lodger.

## LODGERS COMMITMENTS

The lodger is committed :

1. not to bring supplementary people without the letter's permission ;

2. not to sub-rent the accommodations ;
3. the use the accommodations peacefully ;
4. not to smoke in the accommodations ;
5. to leave the accommodations in a good state on day of departure.

If the lodger does not return the apartment in a decent and clean state (bins out, linen put together in one place, washing-up done), the amount of 30 euros can be deducted from the security deposit.

## CANCELLATION

Any cancellations done 2 months prior your set arrival will be reimbursed 50% of the account when booking (or 10% of total rental cost). Pass this limit, the account will be entirely paid in by ParisFlatRent.

**IMPORTANT :** The bank charges to this refund are at the lodgers expense.
